

## BIKE PARK “LA POMA” IN PREMIÀ DE DALT

### RELEASE OF LIABILITY, WAIVER OF CLAIMS, ASSUMPTION OF RISKS AND INDEMNITY AGREEMENT

#### 1. Voluntary participation:

I .....and in the event that I am under the age of 18, have my father / mother .....consent:

That I voluntarily accept to ride the runs, the bikepark, skatepark and jump into the foam pit/resi with or without the use of a bike, skate, scooter, roller, snake or any modalities practiced at La Poma Bike Park in Premià de Dalt, and confirm my / our complete ability to sign this waiver form.

#### 2. Assumption of risk:

I understand that riding and jumping into the BikePark, Skatepark, Foam Pit / Resi and using any of the other facilities such as the bike runs, skate/bike park at La Poma in Premià de Dalt is a highly dangerous activity and I freely accept and fully assume all such risks, dangers and hazards and the possibility of personal injury, death, property damage or loss resulting there from by signing this waiver form.

#### 3. Release of Liability:

In consideration of my participation in biking, riding, skating at La Poma in Premià de Dalt and my use of all services, equipment and facilities at La Poma, I hereby agree as follows to waive any and all claims that I have or may in the future have against the releasees and to release the releasees from any and all liability for any loss, damage, expense or injury, including death, that I may suffer or that my next of kin may suffer, as a result of my participation in activities at La Poma.

To hold harmless and indemnify the releasees for any and all liability for any property damage, loss or personal injury to any third party resulting from my participation in riding at La Poma. This Release Agreement shall be effective and binding upon my heirs, next of kin, executors, administrators and representatives, in the event of my death or incapacity;

This agreement shall also apply to all subsequent Bike Park Pass renewals.

#### 4. Compensation:

The participant and/or the father/mother/guardian (when under the age of 18) by completing the information below assume complete responsibility for all personal damages that could occur while using La Poma Bike park in Premià de Dalt, including third party damages, theft, loss of belongings excluding the risk and acts to the administrators, promoters or employees who look after and take care of the facilities, including cleaning and maintenance staff.

#### 5. Confirmation:

I have carefully read this release agreement and I am aware that by signing it I am waiving certain legal rights between myself and La Poma Bike Park in Premià de Dalt and/or the employees, their administrators and for persons and or companies who provide services to La Poma. I accept that any lawsuit or litigation has to be processed through the jurisdiction of the Tribunal court of Barcelona.
